V. **CODE:**

Fred – CEU Training, Waste & Vents:

Three elements of a waste & vent system to function properly:

Waste Pipe – Conveys only liquid waste free of fecal mater

Trap – Provides liquid seal to prevent sewer gas odors

Vent – Provide air to avoid siphon and balances/equalizes air pressure in the system.

10 story building require a yoke vent or offset stack to prevent pressure changes in the stack

Indirect waste:

- Indirect waste pipe exceeding 5-feet but less than 15-feet shall be directly trapped, but such trap need not be vented.
- No vent from indirect waste piping shall combine with any sewer connected vent. It shall extend separately to the outside air.
- Food prep, Ice used for human consumption etc, shall be separately piped and have a full air gap.

Table 7-5:

- Changes to foot note #2 – added “exceeding one (1) fixture unit.
- Addition to Notes: This table complies with the requirements of section 901.2

Grey Water:

- State Department of Health is developing new regulations for grey water, they regulate disposal of grey water outside.

Code Change:

2000 UPC 502.13 Definition:

Water Heater – An appliance designed primarily to supply hot water and is equipped with automatic controls limiting water temperature to a maximum of two hundred ten degrees (210⁰ F) (90⁰C).

Changed in the 2003 Code and currently is follows:

2009 UPC 502.15 Definition:

Water Heater – An appliance for supplying hot water for domestic or commercial purposes [NFPA 54:3.3.55.7}

UPC sections 505.4 & 505.5 basically outline the temperature & pressure limiting devices per manufactures specs.

The definition of water heater was the only location that identified the maximum of two hundred ten degrees (210⁰ F) (90⁰C) to identify the proper temperature for the T&P relief. Does the chapter think this would warrant looking into a code change proposal?
